Entropy Solution for Doubly Nonlinear Elliptic Anisotropic Problems with Robin Boundary Conditions

We study in this paper nonlinear anisotropic problems with Robin boundary conditions. We prove, by using the technic of monotone operators in Banach spaces, the existence of a sequence of weak solutions of approximation problems associated with the anisotropic Robin boundary value problem. For the existence and uniqueness of entropy solutions, we prove that the sequence of weak solutions converges to a measurable function which is the entropy solution of the anisotropic Robin boundary value problem.

1. Introduction

The aim of this paper is to study the following nonlinear anisotropic elliptic Robin boundary value problem:

$$-\sum_{i=1}^{N} \frac{\partial}{\partial x_{i}} a_{i} \left(x, \frac{\partial u}{\partial x_{i}} \right) + b(u) = f \quad \text{in } \Omega,$$

$$\sum_{i=1}^{N} a_{i} \left(x, \frac{\partial u}{\partial x_{i}} \right) \eta_{i} = -\gamma(u) \quad \text{on } \partial\Omega,$$

where Ω is an open bounded domain of \mathbb{R}^N ($N \ge 3$) with smooth boundary and meas(Ω) > 0, $f \in L^1(\Omega)$, $\eta = (\eta_1, \ldots, \eta_N)$ is the unit outward normal on $\partial\Omega$, and $\gamma(u) = |u|^{r(x)-2}u$. All papers on problems like (1) considered particular cases of function b. Indeed, in [1], Bonzi et al. studied the following problems:

$$-\sum_{i=1}^{N} \frac{\partial}{\partial x_{i}} a_{i} \left(x, \frac{\partial u}{\partial x_{i}} \right) + |u|^{p_{M}(x)-2} u = f \quad \text{in } \Omega,$$
$$\sum_{i=1}^{N} a_{i} \left(x, \frac{\partial u}{\partial x_{i}} \right) \eta_{i} = -|u|^{r(x)-2} u \qquad (2)$$
on $\partial \Omega$

where $f \in L^1(\Omega)$. The authors use minimization technics used in [2] or [3] (see also [4, 5]) to prove the existence and uniqueness of entropy solution.

The Robin type boundary conditions in the variable exponents setting are new and interesting problems and were for the first time studied by Boureanu and Radulescu in [3]. The main difficulty for the study of problem in [3] was the definition of an admissible space of solutions. The authors defined the appropriate space and obtained its properties which permit them to use minimization method to prove the existence of weak solutions to the following problem:

$$-\sum_{i=1}^{N} \frac{\partial}{\partial x_{i}} a_{i}\left(x, \frac{\partial u}{\partial x_{i}}\right) + b(x) |u|^{p_{M}(x)-2} u = f(x, u)$$

in Ω,

 $u \ge 0$ in Ω , (3)

$$\sum_{i=1}^{N} a_i\left(x, \frac{\partial u}{\partial x_i}\right) \eta_i = g\left(x, u\right)$$

on $\partial \Omega$.

Since we consider L^1 -data f instead of the function f(x, u) considered in [3], the suitable notion of solution is the entropy solution introduced by Bénilan et al. in [6] (see also [7]). With the Robin type boundary conditions, the values of the solutions at the boundary must be precise and the notion of solutions considered must include the boundary condition. In this paper, as the function b is more general, it is not possible to use minimization technic to get the existence of solution. Therefore, we used the technic of monotone operators in Banach spaces (see [8]) to get the existence of entropy solutions of (1).

For presenting our main result, we first have to describe the data involved in our problem. Let Ω be a bounded domain in \mathbb{R}^N ($N \ge 3$) with smooth boundary domain $\partial\Omega$ and $\vec{p}(\cdot) =$ ($p_1(\cdot), \ldots, p_N(\cdot)$) such that, for any $i = 1, \ldots, N$, $p_i(\cdot) : \overline{\Omega} \rightarrow$ [2; N) is a continuous function with

$$1 < p_i^{-} \operatorname{ess\,inf}_{x \in \Omega} p_i(x) \le \operatorname{ess\,sup}_{x \in \Omega} p_i(x) p_i^+ < +\infty.$$

For any i = 1, ..., N, let $a_i : \Omega \times \mathbb{R} \to \mathbb{R}$ be a Carathéodory function satisfying the following:

(i) There exists a positive constant C_1 such that

$$|a_i(x,\xi)| \le C_1 \left(j_i(x) + |\xi|^{p_i(x)-1} \right),$$

for almost every $x \in \Omega$ and for every $\xi \in \mathbb{R}$, where j_i is a nonnegative function lying in $L^{p'_i(\cdot)}(\Omega)$, with $(1/p_i(x)) + (1/p'_i(x)) = 1$.

(ii) For $\xi, \eta \in \mathbb{R}$ with $\xi \neq \eta$ and for almost every $x \in \Omega$, there exists a positive constant C_2 such that

$$(a_{i}(x,\xi) - a_{i}(x,\eta)) (\xi - \eta)$$

$$\geq \begin{cases} C_{2} |\xi - \eta|^{p_{i}(x)} & \text{if } |\xi - \eta| \geq 1, \\ C_{2} |\xi - \eta|^{p_{i}^{-}} & \text{if } |\xi - \eta| < 1. \end{cases}$$

(iii) There exists a positive constant C_3 such that

$$a_i(x,\xi) \cdot \xi \ge C_3 \left|\xi\right|^{p_i(x)},\tag{7}$$

for
$$\xi \in \mathbb{R}$$
 and for almost every $x \in \Omega$.

The hypotheses on a_i are classical in the study of nonlinear problems (see [1, 3]).

The function *b* is such that

$$b : \mathbb{R} \longrightarrow \mathbb{R}$$
 is continuous, surjective, nondecreasing
with $b(0) = 0$. (8)

Throughout this paper, for any i = 1, ..., N, we assume that

$$\frac{\overline{p}(N-1)}{N(\overline{p}-1)} < p_i^- < \frac{\overline{p}(N-1)}{N-\overline{p}},$$

$$\frac{p_i^+ - p_i^- - 1}{p_i^-} < \frac{\overline{p}-N}{\overline{p}(N-1)},$$

$$\sum_{i=1}^N \frac{1}{p_i^-} > 1,$$

where $N/\overline{p} = \sum_{i=1}^{N} (1/p_i^{-})$. We put for all $x \in \Omega$,

$$p_{M}(x) \max \{ p_{1}(x), \dots, p_{N}(x) \},$$

$$p_{m}(x) \min \{ p_{1}(x), \dots, p_{N}(x) \}$$

and for all $x \in \partial \Omega$,

$$p^{\partial}(x) = \begin{cases} \frac{(N-1)p(x)}{N-p(x)} & \text{if } p(x) < N, \\ +\infty & \text{if } p(x) \ge N. \end{cases}$$

We make the following assumption:

$$r \in C\left(\overline{\Omega}\right)$$
with $1 < r^{-} \le r^{+} < \min_{x \in \partial \Omega} \left\{ p_{1}^{\partial}(x), \dots, p_{N}^{\partial}(x) \right\}.$

Note that the function γ is continuous, defined on \mathbb{R} with $\gamma(t)t \ge 0$ for all *t* in \mathbb{R} and $\gamma(0) = 0$.

A prototype example that is covered by our assumptions is the following anisotropic $\vec{p}(\cdot)$ -harmonic system:

$$-\sum_{i=1}^{N} \frac{\partial}{\partial x_i} \left(\left| \frac{\partial u}{\partial x_i} \right|^{p_i(x)-2} \frac{\partial u}{\partial x_i} \right) = f,$$

which, in the particular case when $p_i = p$ for any i = 1, ..., N, is the *p*-Laplace equation.

The rest of the paper is organized as follows. In Section 2, we present some preliminary results. In Section 3, we study the existence and uniqueness of entropy solution.

2. Preliminaries

We recall in this section some definitions and basic properties of anisotropic Lebesgue and Sobolev spaces with variable exponent. Set

$$C_{+}\left(\overline{\Omega}\right) = \left\{p \in C\left(\overline{\Omega}\right) \text{ such that } \min_{x \in \overline{\Omega}} p\left(x\right) > 1\right\}.$$

For any $p \in C_+(\overline{\Omega})$, the variable exponent Lebesgue space is defined by

$$L^{p(\cdot)}(\Omega) \left\{ u : \Omega \right.$$

$$\longrightarrow \mathbb{R}, \text{ measurable such that } \int_{\Omega} |u|^{p(x)} dx < \infty \right\},$$

endowed with the so-called Luxemburg norm

$$\left| u \right|_{p(\cdot)}$$
 inf $\left\{ \lambda > 0 \text{ such that } \int_{\Omega} \left| \frac{u(x)}{\lambda} \right|^{p(x)} dx \le 1 \right\}.$ (16)

The $p(\cdot)$ -modular of the $L^{p(\cdot)}(\Omega)$ space is the mapping $\rho_{p(\cdot)}$: $L^{p(\cdot)}(\Omega) \to \mathbb{R}$ defined by

$$\rho_{p(\cdot)}(u) \int_{\Omega} |u|^{p(x)} dx.$$

For any $u \in L^{p(\cdot)}(\Omega)$, the following inequality (see [9, 10]) will be used later:

$$\min\left\{ |u|_{p(\cdot)}^{p^{-}}; |u|_{p(\cdot)}^{p^{+}} \right\} \leq \rho_{p(\cdot)} (u)$$

$$\leq \max\left\{ |u|_{p(\cdot)}^{p^{-}}; |u|_{p(\cdot)}^{p^{+}} \right\}.$$

For any $u \in L^{p(\cdot)}(\Omega)$ and $v \in L^{q(\cdot)}(\Omega)$ with (1/p(x)) + (1/q(x)) = 1 in Ω , we have the following Hölder type inequality:

$$\left| \int_{\Omega} uv \, dx \right| \le \left(\frac{1}{p^{-}} + \frac{1}{q^{-}} \right) |u|_{p(\cdot)} \, |v|_{q(\cdot)} \,. \tag{19}$$

If Ω is bounded and $p, q \in C_+(\overline{\Omega})$ such that $p(x) \leq q(x)$ for any $x \in \Omega$, then the embedding $L^{q(\cdot)}(\Omega) \hookrightarrow L^{p(\cdot)}(\Omega)$ is continuous (see [11, Theorem 2.8]).

Herein, we need the following anisotropic Sobolev space with variable exponent:

$$W^{1,\vec{p}(\cdot)}(\Omega) \left\{ u \in L^{p_{M}(\cdot)}(\Omega) \text{ such that } \frac{\partial u}{\partial x_{i}} \\ \in L^{p_{i}(\cdot)}(\Omega), \ i = 1, \dots, N \right\}.$$

 $W^{1,\vec{p}(\cdot)}(\Omega)$ is a separable and reflexive Banach space (see [2]) under the norm

$$\|u\|_{\vec{p}(\cdot)} = |u|_{p_M(\cdot)} + \sum_{i=1}^N \left|\frac{\partial u}{\partial x_i}\right|_{p_i(\cdot)}.$$

We need the following embedding and trace results.

Theorem 1 (see [9, Corollary 2.1]). Let $\Omega \in \mathbb{R}^N$ $(N \ge 3)$ be a bounded open set and for all i = 1, ..., N, $p_i \in L^{\infty}(\Omega)$, $p_i(x) \ge 1$ a.e. in Ω . Then, for any $q \in L^{\infty}(\Omega)$ with $q(x) \ge 1$ a.e. in Ω such that

$$\operatorname{ess\,inf}_{x\in\Omega}\left(p_{M}\left(x\right)-q\left(x\right)\right)>0,\tag{22}$$

one has the compact embedding

$$W^{1,\vec{p}(\cdot)}(\Omega) \hookrightarrow L^{q(\cdot)}(\Omega).$$

Theorem 2 (see [3, Theorem 6]). Let $\Omega \in \mathbb{R}^N$ $(N \ge 2)$ be a bounded open set with smooth boundary and let $\vec{p}(\cdot) \in (C_+(\overline{\Omega}))^N$, $r \in C(\overline{\Omega})$ satisfy the condition

$$1 \le r(x) < \min\left\{p_1^{\partial}(x), \dots, p_N^{\partial}(x)\right\}, \quad \forall x \in \partial \Omega.$$
 (24)

Then, there is a compact boundary trace embedding

$$W^{1,\tilde{p}(\cdot)}(\Omega) \hookrightarrow L^{r(\cdot)}(\partial\Omega).$$
(25)

We introduce the numbers

$$q = \frac{N(\overline{p} - 1)}{N - 1},$$

$$q^* = \frac{N(\overline{p} - 1)}{N - \overline{p}} = \frac{Nq}{N - q}.$$

The following result is due to Troisi (see [12]).

Theorem 3. Let $p_1, ..., p_N \in [1, +\infty)$; $g \in W^{1, (p_1, ..., p_N)}(\Omega)$ and

$$q = (\overline{p})^* \quad if \ (\overline{p})^* < N,$$

$$q \in [1, +\infty) \quad if \ (\overline{p})^* \ge N.$$

Then, there exists a constant $C_4 > 0$ depending on $N, p_1, ..., p_N$ if $\overline{p} < N$ and also on q and meas (Ω) if $\overline{p} \ge N$ such that

$$\left\|g\right\|_{L^{q}(\Omega)} \leq C_{4} \prod_{i=1}^{N} \left[\left\|g\right\|_{L^{p_{M}}(\Omega)} + \left\|\frac{\partial g}{\partial x_{i}}\right\|_{L^{p_{i}}(\Omega)}\right]^{1/N}.$$
 (28)

In this paper, we will use the Marcinkiewicz space $\mathcal{M}^{q}(\Omega)$ $(1 < q < +\infty)$ as the set of measurable functions $g : \Omega \to \mathbb{R}$ for which the distribution function

$$\lambda_{g}(k) = \max\left(\left\{x \in \Omega : \left|g(x)\right| > k\right\}\right), \quad k \ge 0$$
(29)

satisfies an estimate of the form

$$\lambda_g(k) \le Ck^{-q}$$
, for some finite constant $C > 0$. (30)

We will use the following pseudonorm in $\mathcal{M}^q(\Omega)$:

$$\|g\|_{\mathcal{M}^{q}(\Omega)} \inf \left\{ C > 0 : \lambda_{g}(k) \le Ck^{-q}, \ \forall k > 0 \right\}.$$

For any k > 0, the truncation function T_k is defined by

$$T_k(s) = \max\{-k; \min\{k; s\}\}.$$

It is clear that $\lim_{k \to +\infty} T_k(s) = s$ and $|T_k(s)| = \min\{|s|; k\}$.

In order to simplify the notation, for any $v \in W^{1,\vec{p}(\cdot)}(\Omega)$, we use v instead of $v_{|_{\partial \Omega}}$ for the trace of v on $\partial \Omega$.

Set $\mathcal{T}^{1,\vec{p}(\cdot)}(\Omega)$ as the set of the measurable functions $u : \Omega \to \mathbb{R}$ such that, for any k > 0, $T_k(u) \in W^{1,\vec{p}(\cdot)}(\Omega)$. We define the space $\mathcal{T}^{1,\vec{p}(\cdot)}_{\mathrm{tr}}(\Omega)$ as the set of functions $u \in \mathcal{T}^{1,\vec{p}(\cdot)}(\Omega)$ such that there exists a sequence $(u_n)_n \subset W^{1,\vec{p}(\cdot)}(\Omega)$ satisfying

 a.e. in Ω ,
 $\frac{\partial T_k(u_n)}{\partial x_i} \longrightarrow \frac{\partial T_k(u)}{\partial x_i}$ in $L^1(\Omega)$, $\forall k > 0$,

there exists a measurable function v on $\partial \Omega$ such that u_n

$$\rightarrow \nu$$
 a.e. on $\partial \Omega$.

We need the following lemma proved in [13].

Lemma 4. Let *g* be a nonnegative function in $W^{1,\vec{p}(\cdot)}(\Omega)$. Assume $\overline{p} < N$ and there exists a constant C > 0 such that

$$\int_{\Omega} \left| T_k(g) \right|^{p_M^-} dx + \sum_{i=1}^N \int_{\{|g| \le k\}} \left| \frac{\partial g}{\partial x_i} \right|^{p_i^-} dx \le C(1+k),$$

$$\forall k > 0.$$

Then, there exists a constant D, depending on C, such that

$$\|g\|_{\mathcal{M}^{q^*}(\Omega)} \le D,\tag{35}$$

where $q^* = N(\overline{p} - 1)/(N - \overline{p})$.

3. Entropy Solutions

The notion of entropy solutions to problem (1) where the data f belongs to $L^{1}(\Omega)$ is the following.

Definition 5. A measurable function $u \in \mathcal{T}_{tr}^{1,\vec{p}(\cdot)}(\Omega)$ is an entropy solution of problem (1) if $b(u) \in L^{1}(\Omega), \gamma(u) \in L^{1}(\partial\Omega)$, and, for every k > 0,

$$\sum_{i=1}^{N} \int_{\Omega} a_{i}\left(x, \frac{\partial u}{\partial x_{i}}\right) \frac{\partial}{\partial x_{i}} T_{k}\left(u-\varphi\right) dx + \int_{\Omega} b\left(u\right) T_{k}\left(u-\varphi\right) dx \qquad (36) + \int_{\partial\Omega} \gamma\left(u\right) T_{k}\left(u-\varphi\right) d\sigma \leq \int_{\Omega} fT_{k}\left(u-\varphi\right) dx,$$

for every $\varphi \in W^{1,\vec{p}(\cdot)}(\Omega) \cap L^{\infty}(\Omega)$.

The existence result is the following theorem.

Theorem 6. Assume that (4)–(12) hold. Then, problem (1) admits at least one entropy solution.

Proof. The proof is done in three steps.

Step 1 (the approximate problem). We define the reflexive space

$$E = W^{1,\vec{p}(\cdot)}(\Omega) \times L^{p_M(\cdot)}(\partial\Omega).$$

Let X_0 be the subspace of *E* defined by

$$X_0 = \{(u, v) \in E : v = \tau(u)\},$$

where $\tau(u)$ is the trace of $u \in \mathcal{T}_{tr}^{1,p(\cdot)}(\Omega)$ in the usual sense, since $u \in W^{1,\vec{p}(\cdot)}(\Omega)$. In the sequel, we will identify an element $(u, v) \in X_0$ with its representative $u \in W^{1,\vec{p}(\cdot)}(\Omega)$.

For any $n \in \mathbb{N}$ and $\varepsilon > 0$, we consider the sequence of approximate problems:

$$\sum_{i=1}^{N} \int_{\Omega} a_{i} \left(x, \frac{\partial u_{n}}{\partial x_{i}} \right) \frac{\partial v}{\partial x_{i}} dx + \varepsilon \int_{\Omega} \left| u_{n} \right|^{p_{M}(x)-2} u_{n} v \, dx$$
$$+ \int_{\Omega} T_{n} \left(b \left(u_{n} \right) \right) v \, dx + \int_{\partial \Omega} T_{n} \left(\gamma \left(u_{n} \right) \right) v \, d\sigma \qquad (39)$$
$$= \int_{\Omega} f_{n} v \, dx,$$

where $f_n = T_n(f)$, and we define an operator A_n by

$$\langle A_n(u), v \rangle = \langle A(u), v \rangle + \int_{\Omega} T_n(b(u)) v \, dx$$

$$+ \int_{\partial \Omega} T_n(\gamma(u)) v \, d\sigma \quad \forall u, v \in X_0,$$

$$(40)$$

where

$$\langle A(u), v \rangle = \sum_{i=1}^{N} \int_{\Omega} a_i \left(x, \frac{\partial u}{\partial x_i} \right) \frac{\partial v}{\partial x_i} dx$$

$$+ \varepsilon \int_{\Omega} |u|^{p_M(x)-2} uv \, dx.$$

Note that

$$\begin{split} \|f_n\|_{\infty} &\leq \frac{\|f\|_1}{\operatorname{meas}\left(\Omega\right)}, \\ \|f_n\|_1 &= \int_{\Omega} |f_n| \, dx \leq \int_{\Omega} |f| \, dx = \|f\|_1, \\ f_n \xrightarrow[n \to +\infty]{} f \text{ in } L^1\left(\Omega\right), \text{ a.e. in } \Omega. \end{split}$$

Assertion 1 (the operator A is of type M). (i) The operator A is monotone. Indeed, for $u, v \in W^{1, \vec{p}(\cdot)}(\Omega)$, we have

$$\langle A(u) - A(v), u - v \rangle = \langle A(u), u - v \rangle + \langle A(v), v \rangle$$

$$- u \rangle = \int_{\Omega} \sum_{i=1}^{N} a_i \left(x, \frac{\partial u}{\partial x_i} \right) \frac{\partial (u - v)}{\partial x_i} dx$$

$$+ \varepsilon \int_{\Omega} |u|^{p_M(x) - 2} u(u - v) dx$$

$$+ \int_{\Omega} \sum_{i=1}^{N} a_i \left(x, \frac{\partial v}{\partial x_i} \right) \frac{\partial (v - u)}{\partial x_i} dx + \varepsilon \int_{\Omega} |v|^{p_M(x) - 2}$$

$$+ \int_{\Omega} \sum_{i=1}^{N} \left[a_i \left(x, \frac{\partial u}{\partial x_i} \right) - a_i \left(x, \frac{\partial v}{\partial x_i} \right) \right]$$

$$+ \left(\frac{\partial u}{\partial x_i} - \frac{\partial v}{\partial x_i} \right) dx + \varepsilon \int_{\Omega} \left(|u|^{p_M(x) - 2} u \right)$$

$$- |v|^{p_M(x) - 2} v (u - v) dx.$$

$$+ \left((u - v) \right) dx$$

Therefore,

$$\langle A(u) - A(v), u - v \rangle \ge 0, \qquad (44)$$

since for i = 1, ..., N, for almost every $x \in \Omega$, $a_i(x, \cdot)$ and $t \mapsto |t|^{p_M(x)-2}t$ are monotone.

(ii) The operator *A* is hemicontinuous. Indeed, for every u, v in $W^{1,\vec{p}(\cdot)}(\Omega)$, let

$$\varphi: t \in \mathbb{R} \longmapsto \varphi(t) = \langle A(u+tv), v \rangle \tag{45}$$

and let $t, t_0 \in \mathbb{R}$ be such that $t \to t_0$. We have $w = u + tv \to w_0 = u + t_0 v$ in $W^{1, \vec{p}(\cdot)}(\Omega)$.

Using the Hölder type inequality, there exists $i_0 \in \{1, ..., N\}$ such that

Let us denote $\psi_{i_0}(x, w) = a_{i_0}(x, \partial w / \partial x_{i_0})$.

- (iii) u_n converges to some measurable function v a.e. in $\partial \Omega$.

$$\begin{split} &\int_{\partial\Omega} T_n\left(\gamma\left(u_n\right)\right) H_{\delta}\left(u_n - M\right) d\sigma \\ &= \int_{\partial\Omega\cap\{(u_n - M)^+/\delta < 1\}} T_n\left(\gamma\left(u_n\right)\right) H_{\delta}\left(u_n - M\right) d\sigma \\ &+ \int_{\partial\Omega\cap\{(u_n - M)^+/\delta \ge 1\}} T_n\left(\gamma\left(u_n\right)\right) H_{\delta}\left(u_n - M\right) d\sigma \\ &= \int_{\partial\Omega\cap\{(u_n - M)^+/\delta < 1\}} T_n\left(\gamma\left(u_n\right)\right) \frac{\left(u_n - M\right)^+}{\delta} d\sigma \qquad (87) \\ &+ \int_{\partial\Omega\cap\{(u_n - M)^+/\delta \ge 1\}} T_n\left(\gamma\left(u_n\right)\right) d\sigma \\ &= \frac{1}{\delta} \int_{\partial\Omega\cap\{0 < u_n - M \ge \delta\}} T_n\left(\gamma\left(u_n\right)\right) (u_n - M) d\sigma \\ &+ \int_{\partial\Omega\cap\{u_n - M \ge \delta\}} T_n\left(\gamma\left(u_n\right)\right) d\sigma \ge 0. \end{split}$$

where $\tilde{a}_i(x,\xi) = -a_i(x,-\xi)$, $\tilde{b}(s) = -b(-s)$, and $\tilde{f}_n = -f_n$. According to (94) we deduce that

$$T_n\left(-b\left(u_n\right)\right) \le \left\|f_n\right\|_{\infty} \quad \forall n > \frac{\left\|f\right\|_1}{\operatorname{meas}\left(\Omega\right)}.$$

and by Fatou's lemma, it follows that

$$\lim_{n \to +\infty} \inf_{\infty} \int_{\Omega} \left(\left| u_n \right|^{p_M(x)-2} u_n - \left| \varphi \right|^{p_M(x)-2} \varphi \right)$$

$$\cdot T_k \left(u_n - \varphi \right) dx \ge \int_{\Omega} \left(\left| u \right|^{p_M(x)-2} u \right)$$

$$- \left| \varphi \right|^{p_M(x)-2} \varphi T_k \left(u - \varphi \right) dx.$$
(104)

We have

$$\begin{split} \int_{\Omega} \left| \left| \varphi \right|^{p_{M}(x)-2} \varphi \right| dx &= \int_{\Omega} \left| \varphi \right|^{p_{M}(x)-1} \varphi dx \\ &\leq \int_{\Omega} \left(\left\| \varphi \right\|_{\infty} \right)^{p_{M}(x)-1} dx \\ &\leq \int_{\left\{ \left\| \varphi \right\|_{\infty} \leq 1 \right\}} \left(\left\| \varphi \right\|_{\infty} \right)^{p_{M}(x)-1} dx \\ &+ \int_{\left\{ \left\| \varphi \right\|_{\infty} > 1 \right\}} \left(\left\| \varphi \right\|_{\infty} \right)^{p_{M}(x)-1} dx \\ &\leq \text{meas} \left(\Omega \right) \\ &+ \left(\left\| \varphi \right\|_{\infty} \right)^{p_{M}^{+}-1} \text{meas} \left(\Omega \right) \\ &< +\infty. \end{split}$$

Then, *u* is an entropy solution of problem (1). That completes the proof of Theorem 6.

We now state the uniqueness result of entropy solution.

Theorem 12. Assume that (4)–(12) hold true and let u be an entropy solution of (1). Then, u is unique.

Proof. The proof is done in two steps.

Step 1 (a priori estimates). We consider the following.

Lemma 13. Assume (4)–(12) and $f \in L^1(\Omega)$. Let u be an entropy solution of (1). Then

$$- \sum_{i=1}^{N} \int_{E_{3}} a_{i}\left(x, \frac{\partial u}{\partial x_{i}}\right) \frac{\partial v}{\partial x_{i}} dx.$$

According to (5) and the Hölder type inequality, we have

$$\begin{split} \left| \sum_{i=1}^{N} \int_{E_{3}} a_{i} \left(x, \frac{\partial u}{\partial x_{i}} \right) \frac{\partial v}{\partial x_{i}} dx \right| \\ &\leq C_{1} \sum_{i=1}^{N} \int_{E_{3}} \left(j_{i} \left(x \right) + \left| \frac{\partial u}{\partial x_{i}} \right|^{p_{i}(x)-1} \right) \left| \frac{\partial v}{\partial x_{i}} \right| dx \\ &\leq C_{1} \sum_{i=1}^{N} \left(\left| j_{i} \right|_{p_{i}'(\cdot)} + \left| \left| \frac{\partial u}{\partial x_{i}} \right|^{p_{i}(x)-1} \right|_{p_{i}'(\cdot), \{h < |u| \le h+k\}} \right) \\ &\cdot \left| \frac{\partial v}{\partial x_{i}} \right|_{p_{i}(\cdot), \{h-k < |v| \le h\}}, \end{split}$$
(139)

where

$$\left\| \left| \frac{\partial u}{\partial x_i} \right|^{p_i(x)-1} \right\|_{p_i'(\cdot),\{h < |u| \le h+k\}}$$

$$= \left\| \left\| \frac{\partial u}{\partial x_i} \right\|_{L^{p_i'(\cdot)}(\{h < |u| \le h+k\})}$$
(140)

Thanks to relation (18) and Lemma 16, the quantity $(|j_i|_{p'_i}) +$

 $\begin{aligned} ||\partial u/\partial x_i|^{p_i(x)-1}|_{p'_i(\cdot),\{h<|u|\leq h+k\}}) \text{ is finite for all } i=1,\ldots,N. \\ \text{According to Lemma 15, the quantity } |\partial v/| \end{aligned}$ $\partial x_i|_{p_i(\cdot),\{h-k<|\nu|\leq h\}}$ converges to zero as h goes to infinity. Consequently, the last integral of (138) converges to zero as hgoes to infinity. Then,

$$\sum_{i=1}^{N} \int_{\{|u-T_{h}(v)| \le k\}} a_{i}\left(x, \frac{\partial u}{\partial x_{i}}\right) \frac{\partial}{\partial x_{i}} T_{k}\left(u - T_{h}\left(v\right)\right) dx$$

$$\geq I_{h} + \sum_{i=1}^{N} \int_{E_{2}} a_{i}\left(x, \frac{\partial u}{\partial x_{i}}\right) \frac{\partial}{\partial x_{i}} \left(u - v\right) dx,$$
(141)

with ${\rm lim}_{h\,\rightarrow\,+\infty}I_h$ = 0. We may adopt the same procedure to treat the second term in (135) to obtain

$$\sum_{i=1}^{N} \int_{\{|v-T_{h}(u)| \le k\}} a_{i}\left(x, \frac{\partial v}{\partial x_{i}}\right) \frac{\partial}{\partial x_{i}} T_{k}\left(v - T_{h}\left(u\right)\right) dx$$

$$\geq J_{h} - \sum_{i=1}^{N} \int_{E_{2}} a_{i}\left(x, \frac{\partial v}{\partial x_{i}}\right) \frac{\partial}{\partial x_{i}} \left(u - v\right) dx,$$
(142)

with $\lim_{h \to +\infty} J_h = 0$.

For the other terms in the left-hand side of (135), we denote

$$K_{h} = \int_{\Omega} b(u) T_{k} (u - T_{h}(v)) dx$$

+
$$\int_{\Omega} b(v) T_{k} (v - T_{h}(u)) dx,$$

$$L_{h} = \int_{\partial \Omega} \gamma(u) T_{k} (u - T_{h}(v)) d\sigma$$

+
$$\int_{\partial \Omega} \gamma(v) T_{k} (v - T_{h}(u)) d\sigma.$$
 (143)

We have

$$b(u) T_k (u - T_h(v)) \longrightarrow b(u) T_k (u - v)$$

a.e. in Ω since $h \longrightarrow +\infty$, (144)
 $|b(u) T_k (u - T_h(v))| \le k |b(u)| \in L^1(\Omega)$.

Then, by the Lebesgue dominated convergence theorem, we obtain

$$\lim_{h \to +\infty} \int_{\Omega} b(u) T_k (u - T_h(v)) dx$$

=
$$\int_{\Omega} b(u) T_k (u - v) dx,$$

$$\lim_{h \to +\infty} \int_{\Omega} b(v) T_k (v - T_h(u)) dx$$

=
$$\int_{\Omega} b(v) T_k (v - u) dx.$$

Then,

$$\lim_{h \to +\infty} K_h = \int_{\Omega} \left(b\left(u \right) - b\left(v \right) \right) T_k \left(u - v \right) dx.$$

In the same way, we get

$$\lim_{h \to +\infty} L_{h} = \int_{\partial \Omega} \left(\gamma(u) - \gamma(v) \right) T_{k}(u - v) \, d\sigma.$$

Now, consider the right-hand side of inequality (135). We have

$$\lim_{h \to +\infty} f\left(T_k\left(u - T_h\left(v\right)\right) + T_k\left(v - T_h\left(u\right)\right)\right) = 0$$

a.e. in Ω ,
 $\left|f\left(x\right)\left(T_k\left(u - T_h\left(v\right)\right) + T_k\left(v - T_h\left(u\right)\right)\right)\right| \le 2k \left|f\right|$
 $\in L^1(\Omega)$.

By the Lebesgue dominated convergence theorem, we obtain

$$\lim_{h \to +\infty} \int_{\Omega} f(x) \left(T_k \left(u - T_h(v) \right) + T_k \left(v - T_h(u) \right) \right) dx$$

= 0. (149)

After passing to the limit as *h* goes to $+\infty$ in (135), we get

$$\sum_{i=1}^{N} \int_{\{|u-v| \le k\}} \left(a_i \left(x, \frac{\partial u}{\partial x_i} \right) - a_i \left(x, \frac{\partial v}{\partial x_i} \right) \right) \frac{\partial}{\partial x_i} (u-v) dx$$

$$+ \int_{\Omega} \left(b \left(u \right) - b \left(v \right) \right) T_k (u-v) dx + \int_{\partial \Omega} \left(\gamma \left(u \right) - \gamma \left(v \right) \right) T_k (u-v) d\sigma \le 0.$$

Since *b*, γ , and $a_i(x, \cdot)$ are monotone, then

$$\int_{\Omega} (b(u) - b(v)) T_k (u - v) dx = 0,$$
 (151)

$$\int_{\partial\Omega} \left(\gamma \left(u \right) - \gamma \left(v \right) \right) T_k \left(u - v \right) d\sigma = 0, \tag{152}$$

$$\int_{\{|u-\nu| \le k\}} \sum_{i=1}^{N} \left(a_i \left(x, \frac{\partial u}{\partial x_i} \right) - a_i \left(x, \frac{\partial v}{\partial x_i} \right) \right) \frac{\partial}{\partial x_i} (u-\nu) \, dx$$

$$= 0.$$
(153)

According to (6), we deduce from (153) that

u - v = c a.e. $x \in \Omega$, where *c* is a real constant. (154)

For x fixed in $\partial \Omega$, $s \mapsto |s|^{p(x)-2}s$ is nondecreasing and vanishes at 0. Then,

$$(\gamma(u(x)) - \gamma(v(x))) T_k(u(x) - v(x)) \ge 0,$$

$$\forall x \in \partial\Omega, \ \forall k > 0.$$
 (155)

Now, by inequality above and (152), we deduce that for all $k \in \mathbb{N}^*$ there exists $C_k \subset \partial \Omega$ with meas $(C_k) = 0$ such that, for all $x \in \partial \Omega \setminus C_k$,

$$(\gamma(u(x)) - \gamma(v(x))) T_k(u(x) - v(x)) = 0.$$
(156)

Therefore,

$$(\gamma (u (x)) - \gamma (v (x))) (u (x) - v (x)) = 0,$$

$$\forall x \in \partial \Omega \setminus \bigcup_{k \in \mathbb{N}^*} C_k.$$
 (157)

As $p^- > 1$, the following relation is true for any $\xi, \eta \in \mathbb{R}, \xi \neq \eta$ (cf. [14]):

$$\left(\left|\xi\right|^{p(x)-2}\xi - \left|\eta\right|^{p(x)-2}\eta\right)\left(\xi - \eta\right) > 0.$$
(158)

From inequality above and (157), we get

$$u - v = 0$$
 a.e. on $\partial \Omega$. (159)

Finally as

$$u - v = c$$
 a.e. in Ω ,
 $u - v = 0$ a.e. on $\partial \Omega$, (160)

it follows that

$$u = v$$
 a.e. in Ω . (161)

That completes the proof of Theorem 12.
